STATEMENT

Public Statement: Stavatti Aerospace DDTC Registration and Unblemished Legitimacy as a Defense Contractor

9 October 2025 – Stavatti Aerospace Ltd. affirms its established position as a legitimate defense contractor with a flawless compliance record under the U.S. Department of State's Directorate of Defense Trade Controls (DDTC). Registered since 1994 and with no ITAR violations in over 30 years, Stavatti continues to uphold the highest standards in manufacturing, exporting, and brokering USML items, supporting U.S. national security and global alliances.

Registration and Compliance Record

- **Manufacturer/Exporter (Code M45748):** Renewed annually, with approvals documented from 2001, 2004, and 2022–2025 (current expiration February 28, 2026). This authorizes Stavatti to develop and export defense articles, including military aircraft like the SM-31 Stiletto and SM-39 Razor.
- **Broker (Code K-8265):** Renewed from 2023–2025 (expiration February 28, 2026), enabling facilitation of defense transactions under ITAR Part 129.
- **Historical Continuity:** Initial registration in 1994 under Stavatti Corporation, with renewals confirming ongoing compliance, record keeping (ITAR § 122.5), and annual brokering reports (ITAR § 129.10). No enforcement actions or violations recorded by DDTC.

Key DDTC Approvals for International Marketing

- **Australia (August 21, 1998; Case GC-0233-98):** No objection to proposals for the Stavatti Stalma multi-role aircraft to Australia's Ministry of Defense, converted to an advisory opinion under ITAR § 126.9.
- **Philippines (January 26, 2001; Case GC-0268-00):** Approved presentation for the Stavatti F-26A/B STALMA to the Republic of the Philippines, with provisos restricting sensitive technologies (e.g., COMSEC, GPS-PPS).
- **India (October 27, 2004; Case GC-0593-04):** Guidance for marketing the F-26S variant, demonstrating Stavatti's compliant approach to Direct Commercial Sales.

These approvals, tied to Stavatti's registrations, highlight its role in advancing aerospace systems while adhering to U.S. export controls. Operating from its Headquarters at 9400 Porter Road, Niagara Falls, NY, Stavatti maintains empowered officials, employee training, and secure records, ensuring no unauthorized transfers.

Stavatti's unblemished history reinforces its commitment to ethical defense trade, contributing to innovation without compromise.

Compliance Program

Stavatti maintains a robust ITAR compliance program, as required by DDTC, with trained employees, secure recordkeeping for manufacturing and brokering activities, and oversight by CEO Christopher

Beskar, the senior officer designated in all registration letters. Records are available for inspection by DDTC or Authorized Customs, ensuring transparency and accountability.

Commitment to Excellence

Stavatti's unbroken DDTC registration since 1994 and clean ITAR compliance record underscore its legitimacy as a trusted partner in the defense industry. Operating without reliance on public funding (e.g., no grants from Empire State Development, unlike other firms), Stavatti remains dedicated to advancing aerospace innovation from Niagara Falls, contributing to the region's economic and technological future.
